TERMS AND CONDITIONS

1. Brief Description and Mechanism of the Astro Classic Golden Melody 2018 Mah Sing People's Choice Award ("Award")

- i) Astro Classic Golden Melody ("CGM") 2018 is a Singing Competition Show ("Competition") organized by Measat Broadcast Network Systems Sdn Bhd and/or its affiliates (hereinafter referred to as "Astro" or "Organizer"), and the Grand Final of the Competition will be held on 3rd November 2018 ("Grand Final") at Genting, Arena of Stars and broadcast on the "AEC HD (306)" and "AEC (301)" channels.
- ii) The winner for the Award shall be determined solely by online voting ("the Voting"). The winner will be announced during the telecast of the Grand Final.
- iii) The online voting shall be made available from **10.30pm, 27th October 2018 until 10.00pm, 3rd November 2018** or such other time as may be determined by Astro ("Voting Period") at its sole and absolute discretion.
- iv) Entries received after the Voting Period will not be counted.
- v) The online votes gathered from the server database and will be tallied and the elimination/winner of the Competition will be determined.
- vi) In the event of a tie, the Executive Producer and Producer of the Programme, and/or other Astro representatives shall have the sole discretion to determine the winner for the Award.
- vii) The winner will receive a cash prize (RM 8,888) sponsored by the programme's main sponsor (Mah Sing)

2. Voting mechanics and Eligibility

There will be only one (1) method for Voters to submit their votes which is via online Voting. The Astro Classic Golden Melody 2018 Mah Sing People's Choice Award will be decided by public votes via the voting mechanism provided herein:

Online Voting

- i. The Online Voting is open to worldwide potential voters with basic access to the internet. The voters are required to log in to the website, (<http://thegoldenclub.com/voting>), with a valid The Golden Club Website account (A message box will be prompt for the voters to agree on the Astro Classic Golden Melody 2018 Mah Sing People's Choice Award Terms and Conditions and Privacy Notice that permits the Organizer to access voter's The Golden Club account profile.)
- ii. After logging in, the voters can then begin to vote for their favourite contestant. Each valid The Golden Club account is allowed to vote five (5) times per day for their favourite Contestant.
- iii. The webpage will show the highest ranking of 5 contestants from 28th October 2018 to 2nd November 2018. Final results will be announced during the Grand Final on 3rd November 2018 at Genting, Arena of Stars.
- iv. Online Voting Period shall start from **10.30pm, 27th October 2018 until 10.00pm, 3rd November 2018**, or such other time as may be determining by Astro at its sole and absolute discretion. By the cut-off time 1000pm on 3rd November 2018, the website will display the percentage of votes for each contestant. The "vote" button will be removed upon the end of the Online Voting Period.
- v. The organizer reserves the right to amend or modify the mechanism.

The Online Voting is open to Worldwide of all ages ("Voters") with every IP address provided always that any Voters under the age of eighteen (18) years must seek parental and/or guardian approval before participating in the Online Voting. ASTRO considers it the responsibility of parents and/or guardian to monitor their children's (who are below the requisite age) participation in the Online Voting.
